- (2) to receive the printed version of all future Corporate Communication by mail only.

A notification of the publication of Corporate Communication will be sent to you by post when the relevant Corporate Communication is published on the Company's website.**

If you choose to receive the Corporate Communication in printed form, the Company will send the printed version of the Corporate Communication to you until you notify the Share Registrar in writing or send a notice by email to [ir@tradelink.com.hk](mailto:ir@tradelink.com.hk) that you wish to receive the Corporate Communication by electronic means through the Company's website (i.e. the Website Version). You have the right at any time by reasonable notice to send a notification in writing to the Company c/o the Share Registrar or by the email to the email address as indicated above specifying your name, address and request to change the means of receipt of the Corporate Communication.
